

In accordance with paragraph (2) of Article 10 and paragraph (4) of Article 102, paragraph (1) of Article 105 and paragraph (1) of Article 106 of the Aviation Act ("Official Gazette of the Republic of North Macedonia" No.14/24) the Director General of the Civil Aviation Agency endorsed the following

REGULATION ON REGISTRATION OF AIRCRAFT

General provisions

Article 1

This Regulation prescribes the special requirements for registration and deregistration of civil aircraft from the Civil Aircraft Register of the Republic of North Macedonia, the form, content and the procedure for its record keeping, as well as the form, content and the records of certificates of registration and deregistration of aircraft and the procedure for their issuance and change.

Article 2

(1) In the Civil Aircraft Register of the Republic of North Macedonia (herewith: Aircraft Register) all aircraft are entered in accordance with the ICAO standards.

(2) In respect to the unmanned aircraft, only unmanned aircraft which design is subject to certification are entered into Aircraft Register.

Special conditions for entering of the aircraft in the Aircraft Register

Article 3

(1) Aircraft is entered into the Aircraft Register if the following special conditions are met:

- the aircraft meets the airworthiness requirements prescribed by the Aviation Act and the regulations adopted on the basis of that act,
- the aircraft operator is a domestic natural person or a foreign natural person with residence permit in the Republic of North Macedonia or is a legal entity registered and with principal place of business in the Republic of North Macedonia,
- the aircraft having MTOW above 5700 kg has a type certificate issued or recognized by EASA,
- the aircraft having MTOW above 5700 kg has airworthiness export certificate issued by the competent authority of the country where it was previously registered, if that country issues that this kind of certificate,
- the aircraft meets the noise and other emissions requirements prescribed by the Aviation Act and the regulations adopted on the basis of that Act, if they apply to that aircraft,
- the aircraft operator has proof of ownership or an approved dry lease agreement in accordance with Article 103 of the Aviation Act,
- if it is a new aircraft, the owner must hold a manufacturer statement clarifying that it is a new aircraft and has not been entered in any register and
- if the aircraft was registered in a foreign aircraft register, the owner must possess a Certificate of Deregistration proving that it has been deleted from that

register or a statement from the aviation authorities clarifying that it will be deleted from the foreign Aircraft Register at the time of entry in the Aircraft Register.

(2) Notwithstanding to line 1 paragraph (1) of this Article, an aircraft having MTOW up to 5700 kg and does not meet the requirement of line 1 paragraph (1) of this Article may be temporarily entered in the Aircraft Register.

(3) The temporary registration from paragraph (2) of this Article can last up to 12 months and the Agency issues Temporary Certificate of Registration to an aircraft.

(4) Notwithstanding to paragraphs (1), (2) and (3) of this Article, an unmanned aircraft whose design is subject to certification shall be entered in the Aircraft Register if it meets the requirements from line 1, 2, 6, 7 and 8 paragraph (1) of this Article.

Special conditions for aircraft deregistration from the Aircraft Register

Article 4

(1) An aircraft is deleted from the Aircraft Register if any of the following special conditions are met:

- if the owner, i.e. the aircraft operator is demanding it;
- if the aircraft is destroyed or become permanently unusable for air traffic or withdrawn from use for any other reasons;
- if the aircraft has not had valid Certificate of Airworthiness for the last three years, or
- if the owner, i.e. the operator of the aircraft ceases to comply with the requirements of Article 3 of this Regulation.

(2) An aircraft that is encumbered with a mortgage may be deleted from the Aircraft Register only after the written consent of all mortgagees whose rights are recorded in the Aircraft Register has been submitted.

Form, content and record of certificates for registration and deregistration of aircraft and procedure for their issuance and change

Article 5

(1) The aircraft Certificate of Registration is issued in A5 format on white paper.

(2) The form and content of the Certificate from paragraph (1) of this Article is enclosed in Attachment 1, which is an integral part of this Regulation.

(3) The aircraft Temporary Certificate of Registration is issued in A5 format on white paper.

(4) The form and content of the Certificate from paragraph (3) of this Article is enclosed in Attachment 2, which is an integral part of this Regulation.

(5) The aircraft Certificate of Deregistration is issued in A5 format on white paper.

(6) The form and content of the Certificate from paragraph (5) of this Article is enclosed in Attachment 3, which is an integral part of this Regulation.

Article 6

(1) In order to register or temporarily register an aircraft in the Aircraft Register, issuance or change the Certificate of Registration or Temporary Registration, deletion of an aircraft from the Aircraft Register, i.e., issue a Certificate of Deregistration of an aircraft, the aircraft operator submits written request to the Civil Aviation Agency (hereinafter: Agency).

(2) The request from paragraph (1) of this Article can be submitted in the form and content given in ICAO Doc 10142.

(3) The aircraft operator should report any change of the data entered in the Aircraft Register within 15 days from the day of the change by submitting a written request to the Agency for recording of the change in the Aircraft Register.

(4) The changes entered in the Aircraft Register are also entered in the certificates from paragraph (1) of this Article, if those changes refer to the data entered in them.

Article 7

Together with the requests from Article 6 of this Regulations, the aircraft operator submits evidence of compliance with the requirements from Articles 3 or 4 of this Regulation, respectively, as well as proof of paid administrative tax determined by the Administrative Tax Law and paid the fee determined by the Agency's Tarriff Regulation.

Article 8

- (1) The provisions of the Law on General Administrative Procedure shall be applied subsidiarily to the procedure for issuing, changing of Certificate for Registration/Temporary Registration or Deregistration, unless otherwise determined by this regulation.
- (2) By way of derogation to paragraph (1) of this Article, in the procedures provided for by this Regulation, the parties may submit evidence of compliance with the prescribed requirements in English as well.
- (3) In the procedure for issuance and changing of the Certificate for Registration/Temporary Registration or Deregistration, Doc 10142 of ICAO is applied accordingly.

Article 9

- (1) If the requirements of Article 3 of this Regulation are met, the Agency shall enact a decision for registration or temporary registration of an aircraft to the Aircraft Register, shall issue a Certificate of Registration and update the Aircraft Register.
- (2) If the requirements of Article 4 of this Regulation are met, the Agency shall enact a decision for deletion of an aircraft from the Aircraft Register, shall issue a Certificate of Deregistration and update the Aircraft Register.
- (3) If the Agency determines that the requirements for registration, temporary registration or deletion of an aircraft from the Aircraft Register have not been met, it shall enact a decision to reject the request stating the reasons for the rejection.

Article 10

(1) In the event any of the certificates from Article 5 of this Regulation is lost, at the request of the holder, the Agency will issue a new certificate after announcing the lost in the "Official Gazette of the Republic of North Macedonia" on its own expense.

(2) In the event that any of the certificates from Article 5 of this Regulation is damaged, at the request of the holder, the Agency will issue a new certificate. The applicant should return the damaged certificate to the Agency.

(3) In the procedure for reissuance of the lost or damaged certificates, Doc 10142 of ICAO is applied accordingly.

Form, content and manner of Aircraft Register record keeping

Article 11

The Agency keep record of the registration, temporary registration and deregistration aircraft as well as for the issued certificates and submitted documentation and proves in the Aircraft Register.

Article 12

Aircraft Register shall consist of a main book and documents list and additional lists.

Article 13

(1) The main book is composed of one or more books in A4 format that are marked with ordinal numbers.

(2) Each of the books from item (1) of this Article contain a certain number of inserts that are marked with ordinal numbers.

(3) The inserts of the main book consist of a registration form, ownership and mortgage sheet.

(4) Each aircraft is recorded in a separate insert.

(5) The form and the content of the main book is given in Attachment 4, which is an integral part of this Regulation.

Article 14

(1) Registration of an aircraft in the Registration Form and Ownership Sheet of the Aircraft Register is performed based on the Decision enacted in accordance with Article 9 of the Regulation.

(2) In the insert of the Registration Form of the Aircraft Book registration mark, type certificate and other aircraft data are entered.

(3) In the insert of the Registration Form in the Unmanned Aircraft Book registration mark, type certificate and other unmanned aircraft data are entered.

(4) In the insert of the Ownership Sheet the owner/aircraft operator first and last name, address, e-mail address and contact telephone number), data for obtaining ownership, i.e. rights to operate the aircraft are entered.

(5) Registration of the rights for the aircraft into the Mortgage Sheet of the Aircraft Register is performed based on the evidence for mortgage right.

(6) In the insert of the Mortgage Sheet of the Main Book the data for mortgage type, mortgagor and mortgagee, mortgage amount, data for entering and deletion of mortgage and notes prescribed by Law on Contractual and Real Right Relations in Respect of the Aviation Transport are entered.

Article 15

(1) Documents List contains the documents and the certificates on the basis of which the registration of the aircraft was carried out in the registration form, mortgage sheet and ownership sheet, the decisions made by the Director General of the Agency and other documents related to registration, i.e. deregistration of the aircraft from the Aircraft Register.

(2) The form and the content of the Documents List is given in Attachment 5 that is an integral part of this Regulation.

Article 16

Beside the Main Book and Documents List of Article 12 of this Regulation, the following additional lists are held:

1. List of Registered Aircraft entered in the Aircraft Register given in Attachment 6 as an integral part of this Regulation;
2. List of Deregistered Aircraft from the Aircraft Register given in Attachment 7 as an integral part of this Regulation; and
3. List of Aircraft Owners/Operators in which the natural and legal persons who have the right to dispose of or use the aircraft given in Attachment 8 as an integral part of this Regulation.

Article 17

The data from the Main Book is submitted to the Central Registry of the Republic of North Macedonia.

Article 18

(1) For the data from the Aircraft Register the Agency shall keep record in electronic format also and shall enter them in the ICAO electronic base, in a manner and in a procedure determined by ICAO rules for providing valid data for aircraft registered in a signatory country, based on Article 21 of the Convention on International Civil Aviation.

(2) Based on Article 21 from the Convention on International Civil Aviation, on demand by any other ICAO contracting State, the Agency submits information concerning the registration and ownership of any particular aircraft registered in Aircraft Register.

Article 19

The timely updating of the Aircraft Register, its access, the security of the information contained in it, the maintenance of a backup data system that will ensure their continuity in the event of large-scale disasters, as well as the archiving of data that are not active, are determined by the Agency with internal procedure according to ICAO Doc 10142.

Transitional and final provisions

Article 20

(1) The provisions from this Regulation referring to unmanned aircraft will commence to apply from 1 January 2025.

(2) From the day the provisions of paragraph (1) of this Article commence the application, the certificates of registration of unmanned aircraft that do not have certified type issued in accordance with Registration on the form, content, record - keeping and procedure for issuance and modification of the aircraft registration certificate and the temporary aircraft registration certificate ("Official Gazette of the Republic of North Macedonia" No. 294/21), shall cease to be valid and the Agency will delete them from the Unmanned Aircraft Register.

(3) The aircraft Certificates of Registration issued in accordance with the Regulation on the form, content, record- keeping and procedure for issuance and modification of the aircraft registration certificate and the temporary aircraft registration certificate ("Official Gazette of the Republic of North Macedonia" No. 294/21), the Agency will replace them with certificates for registration according to this Regulation no later than December 31, 2024.

Article 21

From the day of entry into force of this Regulation, The Regulation on the form, content, record- keeping and procedure for issuance and modification of the aircraft registration certificate and the temporary aircraft registration certificate ("Official Gazette of the Republic of North Macedonia" No. 294/21 and The Regulation on the form, content and manner of keeping the Aircraft Register, as well as the data submitted to the Central Register of the Republic of Macedonia ("Official Gazette of the Republic of Macedonia" No. 20/11 and 66/19) shall cease to apply.

Article 22

This Regulation shall enter into force on the day following its publication in the "Official Gazette of the Republic of North Macedonia".
